Entry Fee: For Each Event \$25.00 Per Run **No qualified dogs entering a New Zealand or Island championship will be eligible to compete without an official stud book registration number. Late qualified dogs may use an official receipt number if time does not permit receiving a registration number.**

Late Entries: **Entries Close 12 April 2021.** Definitely no late entries accepted (except for dogs qualifying for the first time), after the closing date. These will be accepted up to 12 noon on Monday 17th May 2021.

Competitors: Please note that they will take their turn as drawn or forfeit their right to compete in that event.

Championships: The first seven dogs in each event in the South Island Championships will contest the New Zealand Championships by competing in the second run.

Prizes: A trophy to the value of at least \$1000 will be awarded to the winners of each New Zealand Championship event.

The aggregate points awarded to each dog in the first South Island run, and the second New Zealand run, will determine the allocation of prize money as follows:

In Each New Zealand Championship Event:

1st \$1500 2nd \$900 3rd \$600 4th \$450 5th \$350 6th \$250 7th \$200

Total prize money in each event \$4250 4 Events: \$4250 x 4 = \$17,000

The sweepstake percentage system of funding is now replaced by allocating \$19.50 of the \$25.00 entry fee of each dog actually competing at the Championships, towards the prize money pool. The prize money as listed is guaranteed by the New Zealand Sheep Dog Trial Association.

QUALIFYING CRITERIA

TUX SOUTH ISLAND AND NEW ZEALAND CHAMPIONSHIPS TRIALS 2021 Southland Centre

To qualify for entry dogs must have gained 6 qualification points in 2021
Open Standard Events (1st place 5 points, 5th place 1 point).
It is the competitor's responsibility to correctly state Club where points earned.

1996 Council Ruling

At all Centre Championships the top five dogs irrespective of domicile and the top five centre dogs if not placed in the Open qualify to run at a New Zealand Championship. Competitors must state the first 6 points earned by their dogs in the qualifying period.



OVIS CLEARANCE CERTIFICATES COMPETITORS PLEASE NOTE!

At all dog trials at every centre and club in New Zealand it is mandatory that “All classes and types of dogs entering trial grounds must have Ovis Certificates of no more than 30 days prior to trial.” This approved Council recommendation, without exception, is to be strictly enforced and applies to all dogs, competing or otherwise, present on trial grounds. Dogs are to remain in vehicles until certificates have been checked.
