**Postal Entry:** Complete the entry form from either the 2021 trial date book or download it from the website. Post or e-mail the completed form to the championship secretary. You may send your payment by cheque with the entry form or pay by direct credit to the correct bank account.

**Direct Credit Payments:** If you are paying by direct credit/on-line banking you need to ensure that you include your name, telephone number and one dog's name so that your entry payment can be identified; (refer to the example below):

Entry Fee: For Each Event \$25.00 Per Run **No qualified dogs entering a New Zealand or Island championship will be eligible to compete without an official stud book registration number. Late qualified dogs may use an official receipt number if time does not permit receiving a registration number.**

Late Entries: **Entries Close 5<sup>th</sup> April 2021.** Definitely no late entries accepted (except for dogs qualifying for the first time) after the closing date. These will be accepted up to 12 noon on Monday 26<sup>th</sup> April 2021.

Competitors: Please note that they will take their turn as drawn or forfeit their right to compete in that event.

Prizes: A trophy to the value of at least \$400 will be awarded to the winners of each Island Championship event. The aggregate points awarded to the seven dogs in each event will determine the allocation of prize money as follows:

#### IN EACH EVENT:

1<sup>st</sup> \$1250 2<sup>nd</sup> \$800 3<sup>rd</sup> \$600 4<sup>th</sup> \$450 5<sup>th</sup> \$350 6<sup>th</sup> \$250 7<sup>th</sup> \$150

Total prize money in each event = \$3850 4 Events: \$3850 x 4 = \$15,400

The sweepstake percentage system of funding is now replaced by allocating \$19.50 of the \$25.00 entry fee of each dog actually competing towards the prize money pool. The prize money as listed is guaranteed by the New Zealand Sheep Dog Trial Association.

### OVIS CLEARANCE CERTIFICATES – COMPETITORS PLEASE NOTE!

At all dog trials at every centre and club in New Zealand it is mandatory that “all classes and types of dogs entering trial grounds must have Ovis certificates of no more than 30 days prior to the trial.” This approved Council recommendation, without exception, is to be strictly enforced and applies to all dogs, competing or otherwise, present on the trial grounds. Dogs are to remain in vehicles until certificates have been checked.

# QUALIFYING CRITERIA

## TUX NORTH ISLAND CHAMPIONSHIP TRIALS 2021 Wairarapa & Southern Hawkes Bay Centre

To qualify for entry dogs must have gained 5 qualification points in 2021

Open Standard Events (1st Place 5 points, 5th Place 1 point).

It is the competitor's responsibility to correctly state the club where points earned.

### 1996 Council Ruling

At all Centre Championships and provincial Centre Championships the top five dogs irrespective of domicile and the top five Centre dogs if not placed in the Open qualify to run at an Island or New Zealand Championship.

Competitors residing in the Centre conducting an Island Championship may compete with one (1) qualification point.

Competitors must state the first 5 points earned by their dog(s) in the qualifying period.
